O Arinto dos Açores é uma casta autóctone e exclusiva das ilhas dos Açores, tendo em comum com o Arinto do continente apenas o nome e a boa acidez. Num terroir único no mundo, no meio do oceano Atlântico, na base da montanha vulcânica do Pico, as vinhas estão plantadas nas fendas da rocha, bem junto ao mar, onde se ouve o «cantar do caranguejo», pois é aqui que há mais sol e calor. Esta proximidade, por vezes, de escassos metros, obriga à proteção da vinha por muros (currais), dos ventos fortes e salinos do Atlântico. Esta edição limitada de 1600 garrafas expõe todo este potencial, num vinho puro, mineral, tenso e com uma salinidade de algo que só poderia ter nascido no mar.

Arinto dos Açores is a unique grape varietal native to the Azores Islands. Although it shares the same name and good acidity of the mainland Arinto, the grapes are not related. With its unique and unusal terroir, the vines are planted in the rock cracks at the foothills of the volcanic mountain, so close to the ocean that the locals say you can hear «the crabs singing». The vineyards are protected from strong salty ocean winds by walls of rock known as *currais*. This limited edition of 1600 bottles expresses this island potential in a pure and mineral wine with salts that tease the palate, showing its ocean born origin.
